Puppy Deposit Agreement

This agreement is between the owners of Coy's Colorful Kennel, aka Tx Mini Schnauzers, owned and operated by Gabriel and Sabrina Coy, hereinafter referred to as SELLER and

Deposit in the sum of \$ _____ (no less than 50% of the Selling price)

- 1) A deposit in the amount of 50% of the Selling price is required to hold the puppy of your choice. Puppies are sold on a first come, first served basis; therefore, even if a person has expressed interest in a puppy, the puppy is not guaranteed to anyone until the deposit is received. Deposits may be made by cash in person, "US POSTAL" Money Order by mail, or PayPal via a bank account or a credit card. If mailing a Money Order, please notify us via phone or email on the date mailed. We only place the puppy on HOLD for 3 days while the money is in transit. If the money has not been received in the 3 day time frame, the puppy will be place back up for adoption. If paying with PayPal, the Buyer agrees to pay an additional 3% fee to cover the charges associated with PayPal. The 3% fee is NOT deducted from the final payment and does NOT go toward the total Selling price of the Puppy.
- 2) A deposit is FULLY refundable until the puppy reaches 6 weeks of age. If a deposit is received after the puppy turns 6 weeks old, the deposit is non-refundable. Likewise, if the deposit is made prior to the puppy becoming 6 weeks old and the BUYER declines to purchase the puppy after the puppy reaches 6 weeks old, the BUYER forfeits the funds placed for deposit. The deposit can be moved to another currently AVAILABLE puppy or placed on a puppy from a future litter up to 12 months from the date the deposit was received.
- 3) The Final Payment may be made in CASH by the BUYER when picking the puppy up from the Seller or the Final Payment can be made through PayPal if the Buyer pays the remaining balance 7 days prior to pickup or delivery. Again, the Buyer agrees to pay an additional 3% fee to cover the charges associated with PayPal and the fee is not reimbursable. If the Puppy is to be Shipped, the Final Payment, including the Shipping Charges, must be made 7 days prior to the departure date.
- 4) Shipping is not included in the Selling price of the puppy. A fee of \$275 must be added to the selling price to cover the cost of the shipping crate, the health certificate and the plane fare.
- 5) Puppies are sold with Limited Registration unless stated otherwise in the final sales agreement. Buyer agrees to pay an additional fee of \$150 for Full Registration (Breeding Rights). As a Buyer of a puppy with Limited Registration, you agree to have the puppy altered (spayed or neutered) by 12 months of age to prevent any future health concerns associated with unaltered animals and to prevent the unforeseen or planned pregnancy of the animal in this agreement. The Seller is not responsible for any expenses associated with this or any other procedure after the puppy leaves the Seller's premises.
- 6) BUYER understands that the SELLER will not release a puppy to anyone prior to 7 weeks old if being picked up or hand delivered. If the puppy is being shipped via an airlines, the BUYER agrees to wait until the puppy reaches 8 weeks old to be shipped. BUYER agrees to allow the SELLER to determine the appropriate time to ship a small or ill puppy and BUYER understands that this means a puppy may not leave the SELLER until the puppy reaches 10 weeks old in these special circumstances. The SELLER will always do what is in the best interest of the puppy.

The preceding paragraphs contain conditions established to ensure the well being of the dog, but also to uphold and maintain the reputation of quality that Coy's Colorful Kennel has established. The BUYER understands that a puppy WILL NOT be placed on HOLD or marked as SOLD until the MONEY and THIS AGREEMENT have been RECEIVED. The Seller will have the right to enforce this agreement.
