## Sales Contract And Agreement

- 1) The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/dog parasite free and up to date with inoculations, proper nutrition, which consists of a good quality food given at regular intervals, and fresh water available. The Buyer promises to provide a safe environment for the dog, and never allow the dog to roam freely without proper fencing or supervision. The Seller strongly recommends that the puppy/dog be microchipped or tattooed in order to facilitate his return if lost or stolen.
- 2) The Seller guarantees this puppy/dog to be of sound health and temperament at the time of this sale. A health record of all shots and wormings will be provided by the Seller. The Buyer agrees to take this dog to a licensed veterinarian of his choice within 5 days, (120) hours for a physical examination. Should puppy/dog be determined to be in ill health, the cause of which is clearly attributable to the Seller, the dog may, upon signed written diagnosis from said veterinarian, be returned for refund of the purchase price. If this condition (#2) is met by Buyer, Seller agrees to offer a one year (1) guarantee against life threatening genetic defects of this dog. The defect must be determined by a licensed veterinarian and Buyer must obtain a written letter from the veterinarian stating the medical reason for returning the puppy. Buyer acknowledges that if Buyer proceeds with medical treatment instead of immediately returning the puppy, this guarantee is null and void. After the initial 5 day period has passed, no cash refunds will be given; however, the 1 year guarantee will result in a replacement puppy of the same value and sex as the original puppy when one becomes available.
- 3) The Buyers agree to have the animal spayed/neutered at the age recommended by their veterinarian (usually 6 months to 9 months of age) if future breeding is not planned or if a Spay/Neuter Contract has been signed. The Seller is not responsible for any expenses incurred by the Buyer after the purchase date listed herein including but not limited to vet fees, drugs, x-rays, food, vaccinations, supplies, etc.
- 4) If at any time the Buyer can no longer retain possession of this dog, the Seller is to be notified and given first option of resuming full ownership of dog or for the Seller to locate this dog a new home. NO Refunds will be given. Should Seller resume ownership of the dog, Buyer will provide all registration papers and medical records. Under no circumstances will this dog be sold, leased, traded or given away to any pet shop, research lab, animal shelter or similar facility.
- 5) The Buyer agrees to contact the Seller immediately if any questions or concerns arise about the dog, such as housing, diet, health or training. The buyer agrees to keep the seller informed of any treatment as it occurs. This provides the Breeder/Seller with an opportunity to follow up on puppies and gives us important feedback and information on the health or our dogs for future generations.
- 6) Registration papers will be given with the puppy if adopted with Full Registration Rights. If sold with Limited Registration or under a Spay/ Neuter Contract, both parties agree to abide by the contract. It is understood at the time of sale that this is a pet quality dog and it is representative of its breed. It is structurally and temperamentally suited as a companion and/or obedience dog. Training classes are recommended for a happy relationship between the dog and family.

The preceding paragraphs contain conditions established to ensure the well being of the dog, but also to uphold and maintain the reputation of quality that Coy's Colorful Kennel has established. The Buyer's agreements will continue for the dog's life and the Seller will have the right to enforce the agreements.
