- 1) The seller has determined the puppy from this litter shall not be sold with reproduction rights. The Buyer acknowledges understanding that this puppy must be altered. It is understood by all parties that said puppy is being sold as a "companion" puppy/ dog and will not be allowed to reproduce at any time in the future. It is also agreed by all parties that said puppy will be released to leave Buyer upon payment of adoption fees; however all registration papers will be held by Buyer until proof of alteration is given.
- 2) Puppy Registration papers shall be provided to Buyer after supplying Seller with a veterinarian's letter as proof of a spay/neuter at 6 months of age, but no later than 9 months of age. At the time Seller receives proof of alteration, Seller will contact listed veterinarian for confirmation of surgery and dates performed.
- 3) After verification of alteration by a licensed veterinarian, Seller shall immediately relinquish registration papers to Buyer.
- 4) Buyer understands once Seller receives appropriate verification of alteration, this puppy's registration papers will be released with limited registration. Limited Registration means that litters produced by the dog are not eligible for registration. It also means this dog is eligible to compete in all licensed events except breed competition at a licensed dog show provided dog meets other show requirements in order to compete.
- 5) Both parties, Buyer and Seller, agree that this spay/ neuter contract constitutes final notice of the spay/ neuter requirement and no further notice is required to institute legal action for violation of the terms of this contract. If is agreed by both parties, should Buyer fail to spay/ neuter said puppy by 9 months of age, ___/___/___, this will be a breach of contract and will result in forfeiture of the Miniature Schnauzer and the adoption fee (except in the case of delay for medical reasons verified by a licensed veterinarian) or Buyer shall pay for Full Registration Rights for an additional \$350.00 fee.

Benefits of Spaying / Neutering:

- Prevents unwanted pregnancy and complications arising from pregnancy and delivering in a female
- Prevents the heat cycle of the female that usually occurs every six months and last approximately 12-14 days
- Reduces the urge to roam, making it less likely your pet will contract a disease, get in a fight, or become a victim of cruelty, poison or traffic
- Reduces or eliminates the possibility of disease in the reproductive system
- Eliminates testicular tumors and reduces prostate gland problems in males
- If done early enough, will most likely prevent a male from marking
- Reduces unwanted litters, therefore reducing needless euthanasia in our shelters

The preceding paragraphs contain conditions established to ensure the well being of the dog, but also to uphold and maintain the reputation of quality that Coy's Colorful Kennel has established. The Buyer's agreements will continue for the dog's life and the Seller will have the right to enforce the agreements.
